Dear Brynhyfryd / Woodland Park Resident,

Last week I received a letter from NPT council which included information about an application for planning permission that the Cuddy Group has made with them. I have checked with my near neighbours and it seems that only properties bordering on the Cuddy land have received this letter. My reason for writing to you is that this development affects the whole of the street and not just those of us that have received letters.

What the Cuddy group would like to do is resume tipping on the land and then build houses. According to the application they have only tipped half of the amount that they need to. That means that there is just as much material again to come. The height of the land is such that it now looks over most of the street. The application also shows that Cuddy intends to pipe the stream that runs behind the houses and build houses on top of the piped stream with the gardens of these houses running down to the boundary. To do this he will need to use bulldozers and earth moving machines, working right on the boundary fence or wall of the properties adjoining this land. He will then build houses on the land that will overlook the street. We are looking at 4 to 5 years of noise, disturbance and dust in the dry summer periods. There are also possible health hazards, we just don't know what has been tipped on this land. Only last year the Cuddy Group were acting suspiciously, digging holes, lorries then tipped into the holes, then the holes were filled in. If they were tipping ordinary soil, why would the Cuddy Group do this ?

I ask that you join me in objecting to this proposal on the following grounds.

- 1. There is too much material that has already been added to the Cuddy land, any more would make it unsafe, it should be taken away rather than more added.
- 2. That the new houses will overlook the street and we will lose our privacy.
- 3. Piping the stream increases the flood risk of the lower parts of Brynhyfryd and Woodland Park. In torrential rain water running off the higher ground will settle in Brynhyfryd and Woodland Park and flood the lower houses.
- 4. The will be excessive noise and disturbance from the tipping, when he pipes the stream then we will have bulldozers and earth movers working right up to our boundary fences, any trees or shrubs will be removed.
- 5. During dry periods dust clouds will form and cause a health hazard for residents who may have asthma or bronchial conditions.
