Dear South Wales Police

Thank you for your reply. Please note the following in relation to this report and the information I have provided to South Wales Police on 4/12/2021.

1. In 2019 I provided the Welsh Assembly Government with information that shows that their policies encourage children to be potentially placed in life threatening danger based upon a scientific misrepresentation.
2. These Welsh Government policies contravene the United Nations Rights of a Child to which the Welsh Government are signatories.
3. The Welsh Assembly Government have used unlawful methods to hide this information that breaches a criminal act covered UK Government law..
4. I believe the role of the South Wales Police is to protect the public of South Wales by enforcing UK Government law.
5. I believe the Ombudsman is a civil servant appointed by the Welsh Assembly Government that has no legal powers over the Welsh Assembly Government or in UK Government law.
- 6 I have reported this to South Wales Police because it is far too complex and important issue for me to deal with and at the end of the day it is not my personal problem unless these policies affect my grandchildren.

To this end will happily provide information gathered in relation to offences committed by public officials but I will not personally take this any further, including to the Ombudsman. I have done my duty as a citizen in reporting it to the police who I believe are the correct organisation to deal with the offence.

This is based upon educational material and courses run by Welsh government funded institutions. My wife and I attended a course in Swansea which included a film of children chasing each other with burning objects and fighting with hammers as part of the normal play process. A film was also shown where the course tutor (a lady) acted inappropriately towards a child. Having brought up 4 children, we were traumatised by the content of the course and initially thought it was a wind up, however, it turned out to be serious and the actual intended form of play for children. I have undertaken detailed research into the educational material made available for the course content and found the material to be intentional child abuse that fails to observe the United Nations Rights of a Child. If you review the book 'First Claim' for sale on a Welsh Government funded charity website Play Wales (link below)

you will note that it states that 'life threatening' play is essential for the development of children, it goes on to describe the forms of life threatening play and then offers the source for this information:

An image of three excerpts from this book is attached (63-deep-play).

top - a statement that life threatening play is essential for a child's personal development.

middle - types of play encouraged - playing in front of traffic, riding a bike on a parapet of a bridge or through fire, climbing high trees over rivers, etc

bottom - the source for this information which can be proven to be a mis-represented.

A play checklist is attached which shows that this life threatening 'deep' play is part of the play curriculum. (94-deep-play)

The following paper which identifies this and provides a 'null hypothesis' of this educational material has been submitted to the and then hidden by the Welsh Assembly Government committee responsible for dealing with such information. This document is attached and is also a linked below.

This is where the offence that I am reporting occurred. The CYPE committee and clerk at the Welsh Assembly have hidden the paper from the public by bypassing WAG protocol/rules which state that they should have discussed this information in public. Hiding this information will have a knock-on effect, in that the policies and educational material that encourage the intentional abuse of children remain in situ. It is probable that children will be harmed and may eventually die as a result of this.

This offence is above my status as a non-government linked individual, but is not above my ability as a parent, grandparent and an analyst/author to identify deliberate actions intended to harm children. If you want to report this to the ombudsman, that's up to you. However as previously stated I believe the offence to breach the UK Government law Misconduct in Public Office. I'll be happy to work with your investigators to identify avenues of investigation and provide information to identify the intended abuse of children, but as far as I am concerned, I have done my duty as a citizen in reporting it to the police (via the 101 service) who I believe are the correct organisation to deal with a breach of UK Government law.
