Thank you for your further email.

It is important to understand, that the CPS and the police are separate authorities. Further, the CPS is not an investigative body and has no power to investigate allegations of crime, therefore, if you believe that a criminal offence has been committed, it should be reported to the police in the first instance so that an appropriate course of action can be taken.

The CPS will only consider allegations following an investigation by the police and the CPS plays no part in the investigation. Any evidence that you have to support your allegations should be referred to the police in the first instance, as they have the power to look into the matter further. This is prior notice that members of this community will potentially act in self defence against enforcement officials of Andrew James Enforcemnet working on behalf of Neath Port Talbot Council Andrew James Enforcement have been informed that NPTC are abusing and are potentially causing harm and death to children and adults in this community.

Our actions will be in line with the 1998 Human Rights Act.

At the point when a magistrates liability order has been awarded against us it can be proven that piublic officials within NPTC have made criminal actions and that as an organisation NPTC are covering up the probability that children will die because of their malpratrice.

The attached image shows the enforcement agent's representative holding documentary evidence of this. Other documentary evidence showing probable harm to children was offered to him but he refused to take the evidence away with him.

The image is taken from a video of his visit to our property which provides evidence of the complete communication interchange. It can be proven beyond reasonable doubt that public officials within Neath Port Talbot Council have and still are committing corporate manslaughter and attempted murder of council tax paying residents and so it is only fair that residents refuse to pay this tax on the basis that the money is being used to cause their deaths.

The company Andrew James Enforcement are aiding and abetting the corporate manslaughter by collecting money to further the crimes of Neath Port Talbot Council because they have been informed of the consequences of their actions.
