I note that you have been sending in many emails recently on the above application, including requests for information. I responded to one myself yesterday about the site notice on a telegraph pole on your property, to which you have sent a further response and question.

I wish to make it clear that even in 'normal' times, my Officers are unable to enter into correspondence on representations on applications due to the volume of representations received (as stated in our notification letters).

For this reason, and due to the number of emails you are sending during a period when we are experiencing

challenging circumstances, I must advise that we will no longer be able to respond to your requests for information or respond to your questions. Instead, as you have done, please submit representations expressing any issues or concerns with the development, and these will be considered as part of our assessment of the application in question.
