 Dear Councillors

Further to my email earlier and your meeting tomorrow the following extracts are what I consider to be key information taken from the document.

The [2008] report advised that dust suppression and a boundary fence were necessary to keep the contaminants from affecting local residents, but since this report was withdrawn and the contamination left unremediated, dust and vapours have been regularly blown towards the houses of residents living next to the site while the Cuddy Group tipped industrial waste. This dust has affected the health of some residents, several of whom have asthma, there are also incidences of children born with mutations and young adults dying from cancer. Some of these young adults used the area of the site known locally as 'the bog' as a play area during childhood.

This report is being submitted to the members of Neath-Port Talbot Council for the verification of information and the opportunity to provide counter evidence to the information and allegations made in this document. It should be noted that the 'personal opinions' of Neath-Port Talbot Council staff members and councillors will be ignored and discounted unless supported by the relevant evidence that supports these opinions.

That no contradictory evidence has been offered by the Neath-Port Talbot Council staff and councillors is the reason why we find ourselves in this situation today, both Councillors Knoyle and Morgan are going to extraordinary lengths to cover up the malpractice. They have been sitting on this information and supporting planning department corruption for 7 weeks. The question is, will you join them tomorrow?
